SUMMARY ANNUAL REPORT FOR HEALTH CARE EMPLOYEES/EMPLOYER DENTAL AND MEDICAL TRUST

This is a summary of the annual report of the Health Care Employees/Employer Dental and Medical Trust (the "Plan"), EIN 94-2356343 for the year ended December 31, 2018. The annual report has been filed with the Pension and Welfare Benefits Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The Plan has contracts with Kaiser Foundation Health Plans, Inc., Chinese Community Health Plan, Fidelity Security Life, Reliance Standard Life Insurance Co., Delta Dental of California, UnitedHealthCare Insurance Company and Symetra Life Insurance Company to provide medical, life and dental benefits. The total premiums paid for the plan year ended December 31, 2018 were \$139,228,527.

Basic Financial Statements

The value of the Plan assets, after subtracting liabilities of the Plan, was \$4,295,636 as of December 31, 2018, compared to \$4,104,511 as of January 1, 2018. During the plan year, the Plan experienced a decrease in its net assets of \$191,125. During the Plan year, the Plan had total income of \$145,372,556, including employer contributions of \$142,204,646, participant contributions of \$3,119,577, and earnings from investments of \$48,333.

Plan expenses were \$145,181,431. These expenses included \$2,408,562 in administrative expenses, and \$142,772,869 in benefits paid to participants and beneficiaries.
